Purpose:

A *Petition to Change Course Enrollment* should be submitted by a student who, with appropriate circumstances, wishes to: (i) add a course after the deadline; (ii) withdraw from a course after the deadline; (iii) change unit total of a course after the deadline; (iv) submit a late study list; (v) request a section change; or (vi) repeat a course for a second time.

NOTE: If you are submitting a late study list, a processing fee of \$200 will be applied to your student account.

Petition Deadlines:

Late Add, Late Change of Unit Total, Section Change:	End of Week 4
Late Withdrawal:	Last day of Classes
Repeat Course for 2nd Time:	Same as Add Deadline
Late Study List:	End of Week 4

Instructions:

Please note that requests for changes should demonstrate exceptional circumstances; otherwise, they are generally denied.

- Contact UAR to make an in-person or phone appointment with a UAR Advisor or Academic Director to determine whether your request is appropriate.
- Write a Personal Statement (up to 1 page) describing why an exception to Faculty Senate course enrollment policies is warranted. Where applicable, discuss the following:
 1. What occurred - description of events
 2. Chronology of events (e.g. specify dates of attendance, interactions and transactions.)
 3. Whom you consulted
- Meet with the UAR Advisor or Academic Director to discuss your request and written statement.
- Obtain appropriate signatures and submit form and Personal Statement to UAR or your Academic Director.

Notification:

You will receive written notification of the results of your petition once it has been reviewed. Notification will be sent to the email address you entered on this form. Petitions may take three weeks to process, although most take less time. Failure to complete any, or part, of the requested information will delay the review of your request. Petitions without all required signatures will not be reviewed. Petitions submitted after the deadline may not be reviewed.
